- ▶ Prospective bidders must have an experience of having completed at least one (1) contract that is similar to the contract to be bid, and the value of which adjusted to current prices using the National Statistics Office (NSO) consumer price indices, must be at least fifty percent (50%) of the Approved Budget of the Contract, and have key personnel and equipment available for the implementation of the contract.
- ▶ Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Revised Implementing Rules and Regulations (Revised IRR) of the Republic Act No. 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
- ▶ Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- ▶ Interested bidders may obtain further information from the DOTC and inspect the Bidding Documents at the address given from 8:00 AM to 5:00 PM.
- ▶ The Bid Documents/Forms will be made available at Unit 56, The Columbia Tower Bldg., Ortigas Avenue, Mandaluyong City upon payment of a specified non-refundable fee to the DOTC Cashier. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) (www.philgeps.gov.ph) and from DOTC (www.dotc.gov.ph) provided that the bidders pay the fee for the Bidding Documents not later than the submission of bids, The Pre-Bid Conference is open to all interested parties.
- ▶ All bids must be accompanied by the bid security in any of the acceptable forms and in the amount stated in the Instructions to Bidders (ITB) Clause 18.
- ▶ Bids will be opened in the presence of the bidders' representatives who choose to attend at the DOTC Conference Room, 16th Floor, The Columbia Tower, Ortigas Avenue, Brgy. Wack-Wack, Mandaluyong City. Late bids shall not be accepted.
