Dear **Mr. Cho:**

This is to inform you that the contract for the *Engagement of an Intelligent Transport Systems and Area Traffic Control Consultant for the Cebu Bus Rapid Transit Project* has been approved by the concerned authorities of the Department of Transportation and Communications in the total amount of **One Hundred Twelve Thousand Fifty Three and 33/100 US Dollars (USD 112,053.33)**, which is inclusive of the following:

1. remuneration of Seventy Three Thousand Three Hundred Thirty Three and 33/100 US Dollars (USD 73,333.33), inclusive of applicable Withholding Tax in the amount of Eighteen Thousand Three Hundred Thirty Three and 33/100 US Dollars (USD 18,333.33);
2. pre-approved reimbursements up to the amount of Twenty Nine Thousand Nine Hundred Twenty US Dollars (USD 29,920.00) which consist of the following:
  - a. airfare with two (2) roundtrips from Manila to Seoul up to the amount of One Thousand Four Hundred US Dollars (USD 1,400.00);
  - b. two (2) roundtrips from Manila to Cebu up to the amount of Three Hundred US Dollars (USD 300.00)
  - c. Daily Subsistence Allowance in the total amount of Twenty Eight Thousand Eighty US Dollars (USD 28,080.00) or Two Hundred Thirty Four US Dollars (USD 234.00) per day for one hundred twenty (120) days;
  - d. Transfer fees up to the amount of One Hundred Forty Dollars (USD 140.00); and
3. the net of applicable taxes, including Value Added Tax in the amount of Eight Thousand Eight Hundred Dollars (USD 8,800.00).

Accordingly, you are hereby directed to commence services in pursuant to the terms and conditions as stipulated in the Contract and the date of commencement shall be within seven (7) calendar days after your receipt of this Notice. The Contract shall be for a period of six (6) person months, subject to extension/renewal at the option of the Head of Procuring Entity, but in no case shall exceed the term of the latter.
