Description

The Department of Transportation National Program Management Office-Bus Rapid Transit intends to procure and engage the services of a Consultant/Appraisal Firm to undertake appraisal of the South Depot for the Metro Manila Bus Rapid Transit-Line 1 located along Carlos Palanca Street, Quiapo, Manila City with an area of 1.57 hectares.

The scope of work for the corresponding Approved Budget for the Contract are as follows:

1. The Consultant/Appraiser firm shall conduct appraisal studies on the bases of Market Value (MV) of the property that shall serve as reference in the proper valuation;
2. The appraisal report shall be made available and submitted within ten (10) working days after INSPECTION of the site and COMPLETION of all necessary documents;
3. Ocular site inspection including the condition of the premises;
4. Validation of local market conditions for comparable properties in accordance with the Philippine Valuation Standards (PVS) and its lot plan, vicinity map and pictures;
5. Provide two (2) hard copies (book bound and duly signed by the appraiser with dry seal) and soft copy (PDF format) of the final appraisal reports;
6. The Consultant/Appraisal Firm must have the following minimum qualifications;
 - (a) Must have at least five (5) years of experience in real estate appraisal;
 - (b) Must have undertaken at least twenty-five (25) appraisal related projects within the last ten (10) years;

- (c) The Consultant's team leader to be assigned to the project should be a Licensed Real Estate Appraiser and must have undertaken at least ten (10) similar appraisal projects;
- (d) Must be accredited by Bangko Sentral ng Pilipinas; and
- (e) PhilGEPS registered.

7. Submit Narrative Appraisal covering the following points:

- A. Brief property identification
- B. Effective date of the valuation and date of report preparation
- C. Property location
- D. Property ownership and property rights appraised
- E. Acreage breakdown and brief list of improvements
- F. Zoning
- G. Highest and best use
- H. Brief summary of subject leases, if any
- I. Value indicated by the cost approach
- J. Value indicated by the income approach
- K. Value indicated by the sales comparison approach
- L. Final value estimate

Bid quotations should be inclusive of the 12% VAT.
