The Republic of the Philippines has received financing from the World Bank toward the cost of the Cebu BRT Project and intends to apply part of the proceeds for consulting services.

The consulting services (the “Services”) include updating and implementation of Social Management Plan for the Cebu BRT Project.

The Consultant will provide expertise for two (2) years (from 2015 to 2017) covering the following areas:

- a. Stakeholder consultation and data collection;
- b. Program design and implementation;
- c. Stakeholder relations office; and
- d. Capacity building of transport groups.

The Department of Transportation and Communications (“DOTC”) now invites eligible consulting firms (“Consultants”) to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The short listing criteria are:

- a) experience of the consulting firm in at least two (2) projects involving social management; and
- b) experience of the consulting firms in at least two (2) projects involving program design of capacity building and implementation.

The attention of the interested Consultants is drawn to paragraph 1.9 of the *Guidelines on Selection and Employment of Consultants under the International Bank for Reconstruction and Development Loans and International Development Association Credits and Grants by World Bank Borrowers*, January 2011 (World Bank Guidelines) setting forth the World Bank’s policy on conflict of interest.

Consultants may associate with other firms in the form of a joint venture or a sub-consultancy to enhance their qualifications.
