

**CONTRACT FOR THE MARINDUQUE AIRPORT
DEVELOPMENT PROJECT
(Construction of Airport Administration Building)**

THIS AGREEMENT, made this _____ day of APR 30 2015, 2015 between the Government of the Republic of the Philippines, thru the Department of Transportation and Communications (DOTC), represented by Assistant Secretary for Project Monitoring and Evaluation LINO H. DABI, with office address at The Columbia Tower, Ortigas Avenue, Mandaluyong City (hereinafter called the "Entity") and Adimre Construction represented by Mr. NOEL B. MARIANO, its General Manager, with office address at Villa Priscilla Subdivision, Cut-Cot, Pulilan, Bulacan (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the Construction of Airport Administration Building for the Marinduque Airport Development Project (hereinafter called "the Works") and the Entity has accepted the Bid for Six Million Two Hundred Ninety Two Thousand Six Hundred Twenty One Pesos and Fifty One Centavos (P6,292,621.51) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) General and Special Conditions of Contract;
 - (b) Drawings/Plans;
 - (c) Specifications;
 - (d) Invitation to Apply for Eligibility and to Bid;
 - (e) Instructions to Bidders;
 - (f) Bid Data Sheet;
 - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Credit line issued by a licensed bank, if any;
 - (l) Notice of Award and the Bidder's conforme thereto;
 - (m) Other contract documents that may be required by existing laws and/or the Entity
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any

defects therein in conformity with the provisions of this Contract in all respects.


