

**CONTRACT FOR THE VIGAN AIRPORT DEVELOPMENT PROJECT**  
**(Construction of Drainage Canal and Proposed Access Road)**

THIS AGREEMENT, made this \_\_\_\_\_ day of \_\_\_\_\_, 2015 between the Government of the Republic of the Philippines, thru the Department of Transportation and Communications (DOTC), represented by Assistant Secretary for Project Monitoring and Evaluation LINO H. DABI, with office address at The Columbia Tower, Ortigas Avenue, Mandaluyong City (hereinafter called the "Entity") and KRB Construction represented by Mr. RICHARD M. NUVAL, its General Manager, with office address at Brgy. Cagsalaosao, Maharlika Highway, Calbayog City, Western Samar (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the Construction of Drainage Canal and Proposed Access Road for the Vigan Airport Development Project (hereinafter called "the Works") and the Entity has accepted the Bid for Five Million Nine Hundred Ninety Two Thousand Four Hundred Seventy Four Pesos and Twelve Centavos (₱5,992,474.12) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
  - (a) General and Special Conditions of Contract;
  - (b) Drawings/Plans;
  - (c) Specifications;
  - (d) Invitation to Apply for Eligibility and to Bid;
  - (e) Instructions to Bidders;
  - (f) Bid Data Sheet;
  - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
  - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
  - (i) Eligibility requirements, documents and/or statements;
  - (j) Performance Security;
  - (k) Credit line issued by a licensed bank, if any;
  - (l) Notice of Award of Contract and the Bidder's conforme thereto;
  - (m) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.


