

**CONTRACT FOR THE CIVIL WORKS OF
LRT LINE-2 EAST (MASINAG) EXTENSION PROJECT
(PACKAGE 1 – CONSTRUCTION OF VIADUCT)**

THIS AGREEMENT, made this 27th day of March, 2015 between the Government of the Republic of the Philippines, thru the DEPARTMENT OF TRANSPORTATION AND COMMUNICATIONS, represented by Undersecretary for Project Implementation and Special Concerns JULIANITO G. BUCAYAN, JR., with office address at The Columbia Tower, Ortigas Avenue, Mandaluyong City (hereinafter called the "Entity") and D.M. CONSUNJI, INC. represented by Mr. JORGE A. CONSUNJI, its Authorized Representative, with office address at DMCI Plaza Bldg., 2281 Don Chino Roces Avenue Extension, Makati City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute Package 1 – Construction of Viaduct for the LRT Line-2 East (Masinag) Extension Project (hereinafter called "the Works") and the Entity has accepted the Bid for Two Billion Two Hundred Seventy Million Pesos (Php 2,270,000,000.00) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) General and Special Conditions of Contract;
 - (b) Drawings/Plans;
 - (c) Specifications;
 - (d) Invitation to Apply for Eligibility and to Bid;
 - (e) Instructions to Bidders;
 - (f) Bid Data Sheet;
 - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Credit line issued by a licensed bank, if any;
 - (l) Notice of Award of Contract and the Bidder's conforme thereto;-
 - (m) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.

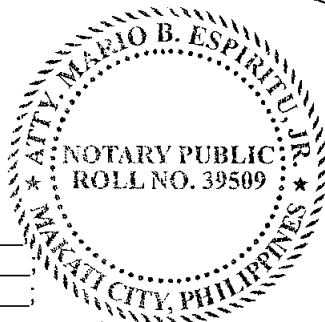

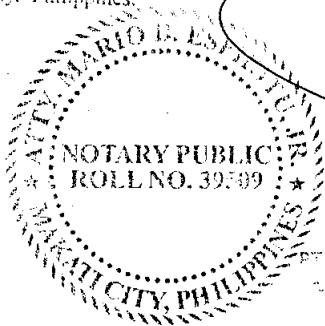
