

**CONTRACT FOR THE PROCUREMENT OF FIREWALL INTRUSION,
DETECTION AND PREVENTION SUBSCRIPTION SUPPORT RENEWAL
FOR THE DOTC – CENTRAL OFFICE**

THIS AGREEMENT, made this _____ day of _____, 2015 between the Government of the Republic of the Philippines, through the Department of Transportation and Communications (DOTC), represented by Assistant Secretary for Procurement CAMILLE R. ALCARAZ, with office address at The Columbia Tower, Ortigas Avenue, Mandaluyong City (hereinafter called the "Entity") and Micro-D International, Inc., represented by Mr. EDWIN DE GALA, SR., Account Manager/Authorized Representative, with office address at 6th Floor, Peninsula Court, 8735 Paseo de Roxas corner Makati Avenue, Makati City (hereinafter called the "Supplier").

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., the Procurement of Firewall Intrusion, Detection and Prevention Subscription Support Renewal for the DOTC – Central Office and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Four Hundred Eighty Two Thousand One Hundred Seventy Five Pesos (Php 482,175.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) Bid Form and the Price Schedule submitted by the Bidder;
 - (b) Schedule of Requirements;
 - (c) Technical Specifications;
 - (d) General Conditions of Contract;
 - (e) Special Conditions of Contract; and
 - (f) Entity's Notification of Award.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

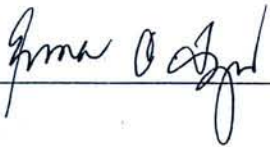

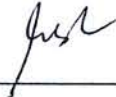
